



AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of duly authorised Partner of Partnership firm "SUN INFRA", the promoter of proposed project "SPACELINK", vide its authorization dated 30.01.2023;

I, MR. BRIJESH PANKAJBHAI PATEL, Authorised Partner of Partnership firm "SUN INFRA", the promoter of the proposed project "SPACELINK", do hereby solemnly declare, undertake and state as under:

- That We, promoters have a legal title to the land on which the development of "SPACELINK" is proposed AND a legally valid authentication of title of such land along with an authenticated copy of the Sale deed of the Land in our firm name (Dastavej) is enclosed herewith.
- 2. That there is term loan of Rs.20,00,00,000/- (Rupees Twenty Crore only) from Aditya Birla Housing Finance Ltd. over the Project.
- That the time period within which the project shall be completed by promoter is 31st December, 2027.
- 4. That seventy per cent of the amounts realised by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- . That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

That I shall get the accounts audited within six months after the end of every financial year by a Chartered Accountant in practice, and shall produce a statement of accounts duly certified and signed by such Chartered Accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
