- I, Mr Mansukh A Sureja Partner of Gurukrupa Developers D.N. Nagar Project, promoter of the on-going project Marina Enclave Wing J, K & L Phase –I, do hereby solemnly declare, undertake and state as under:
- 1. That M/s. Gurukrupa Developers D.N.Nagar Project is the owner of the Land (Occupancy Class- II) and have a legal title Report to the land on which the development of the on-going project Marina Enclave Wing J, K & L Phase -I is carried out by the promoter i.e. to say by M/s Gurukrupa Developers D.N. Nagar Project and a legally Valid authentication of title of project land alongwith an authenticated copy of the documents for development of the Real Estate Project is Enclosed herewith.
- 2. That the project Land is free from all the encumbrances, subject to the mortgage without possession and transfer in respect of the said property and flats to be constructed thereon created by us in favour of Union Bank of India, Goregaon (East) branch and Bank of Baroda, Jaya Talkies compound, S.V.
