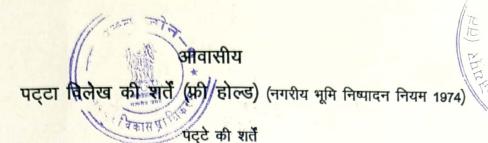

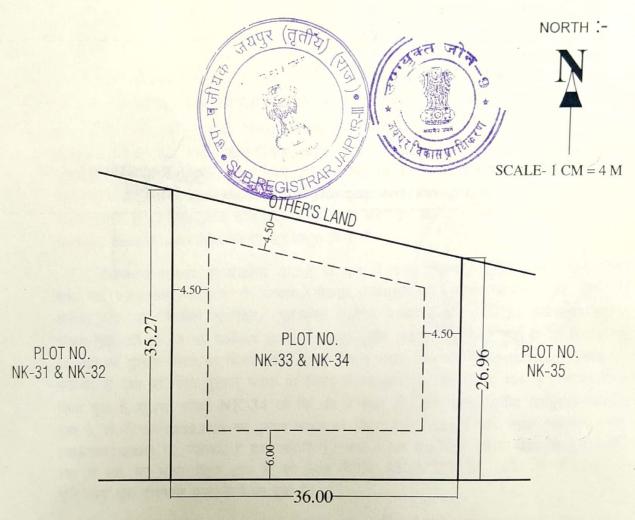

SITE PLAN OF PLOT NO.NK-33 & NK-34 (RESIDENTIAL)

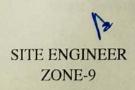
