

As per the field report furnished by The Assistant Executive Engineer (Ele), S7 sub division has submitted the Proposal for Issue of NOC for arranging power Supply for the proposed Residential building to an extent of 400KW in favour of M/s Saipurvi Infrastructure, #11/3, Varthur Hobli Balagere Village, Bangalore in Munnekolala O&M unit, S7 Sub division.

Subject to the following conditions:

- 1. The Regular power supply shall be arranged from the New Feeder of 66/11KV SOBHA dream Acres 66/11kv MUSS.
- 2. Alternate source shall be arranged from the feeder F-9 Feeder of Karchmaranahalli MUSS.
- 3.Execution of the works mentioned above have to be executed from your end at your own cost under **self-execution** basis through a Government Class-I Electrical contractor by paying 10% supervision charges on estimate cost and 18% GST on supervision charges etc. to BESCOM duly observing all BESCOM formalities.
- 4. Payment of augmentation charges for availing power supply and observance of other formalities mentioned in conditions of Supply of Electricity of Distribution licensees in the state of Karnataka shall be followed.
- 5. While applying for power supply to the said building at the above address all conditions as



- 6. Any KPTCL/BESCOM lines passing in your premises shall be shifted at your own cost under self-execution scheme and if any installation existing in the premises shall be surrendered as per Corporate rules and formalities before availing temporary supply for construction purpose or permanent supply. In future, if the requisitioned load is 4000KVA to 7500KVA, land measuring 50mtrX60mtr shall be handed over to KPTCL/BESCOM at free of cost for establishing 66/11kV MUSS.
- 7. The Proposals made shall be explained in detail referring the subject, spot inspection certificate shall be furnished
- 8. In future, if the requested load exceeds 7500KVA, the applicant has to provide prescribed space to establish a 66/11kV MUSS at free of cost to KPTCL.
- 9. Power supply will be arranged to the proposed building based on the provisions of regulations of BESCOM at that time.
- 10. This NOC is issued only for the purpose of obtaining sanction plan for the building from BDA/BBMP/competent authorities and is not a commitment for power sanction from BESCOM. Power supply will be sanctioned when applied, subject to feasibility at that time.
- 11. The approximate load requirement of the above proposed building is 471KVA.
- 12. Feasibility report shall be obtained for proposed new feeders in the station, certificate form the concerned TL&SS regarding availability of space for installation of 11Kv switchgears inside the station premises.
- 13. Further additional requirement of loads in the layout premises suitable space shall be spared For establishing KPTCL station under self-execution.

The Validity of this NOC is for a period of Two years only, from the date of issue.
