



- That, the said land and the FSI available on such land is mortgaged to Aditya Birla Finance Limited under Deed of Mortgage Dated 08/12/2023 registered with Sub Registrar of Assurance at Kurla under serial no. KRL3-26372-2023 dated 22/12/2024 and another Deed of Mortgage Dated 12/12/2023 registered with Sub Registrar of Assurance at Kurla under serial no. KRL3-24223-2023 on 12/12/2024.
- 3. That the time period within which the project shall be completed by Promoter is 31/12/2028.
- 4. That, seventy per cent of the amounts realized by me/Promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That, the amounts from the separate account to cover the cost of the project shall be withdrawn in proportion to the percentage of completion of the project.
- That, the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That, I being the director of the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That, I being the director of the promoter shall take all the pending approvals on time from the competent authorities.
- 9. That, I being the director of the promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.



10. That, I being the director of the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
