It is the primary responsibility of the management of Swastik Enterprises to prepare, produce and maintain all accounting and other relevant supporting records and documents required for the purpose of this certificate. This responsibility includes the design, implementation and maintenance of necessary and appropriate internal control commensurate with the nature and size of entity.
3.	As per self-certification obtained from the management, the amounts withdrawn from the designated bank account are utilized towards project cost only. However, it is not possible for us to verify the end use of funds withdrawn from designated bank account on one-to-one basis since the requisite record for such verification is not available with us. But while certifying on utilization, we have relied on the expenditure as per books of accounts produced before us which shows that the expenditures incurred on the project are more than total amount collected from customers till the end of financial year on cumulative basis.
4.	We have observed that there is shortfall in amount to be deposited in RERA Bank

account amounting to INR 3,70,989.40/-. Further, there is no deviation in the amount collected till date. Hence, on consolidated basis, promoter has deposited more that 70% in RERA Bank account.
