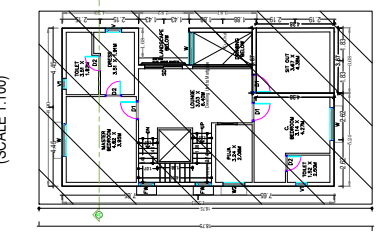
SECTION AT A-A

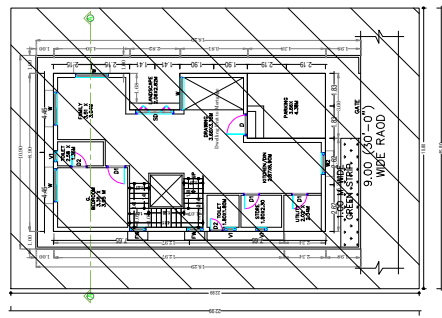
TERRACE FLOOR PLAN
(SCALE 1:100)



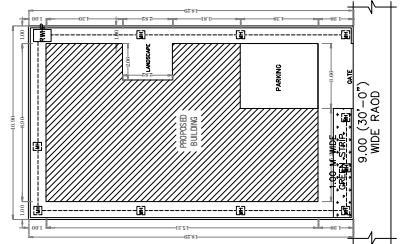
SECOND FLOOR PLAN

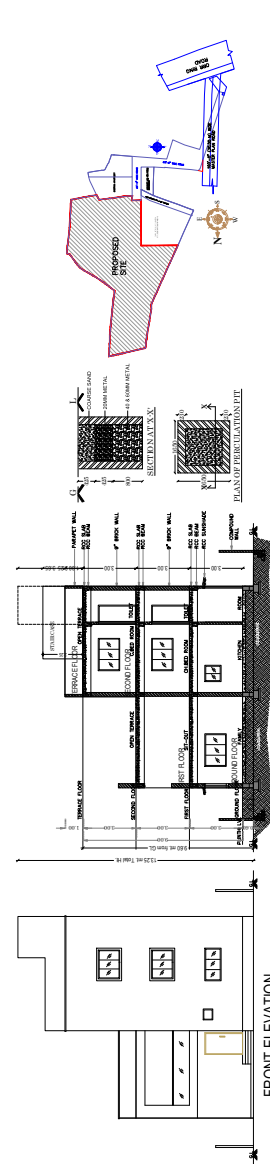

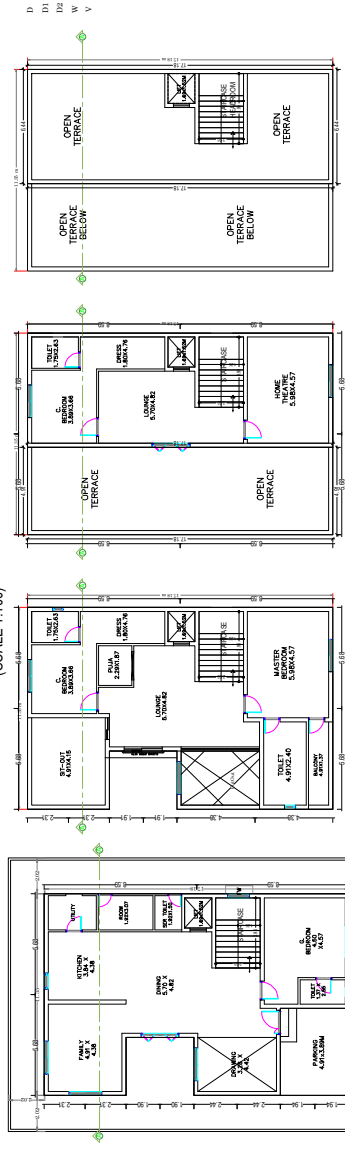

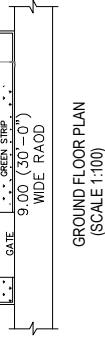
FRONT ELEVATION
