 the Margadarshan Co-Operative Housing Society Limited on 20.03.2023 to redevelop the Said
 Property which was duly registered with the Office of the Sub-registrar of Assurances at
 Andheri under serial No. BDR18-4818-2023.
- As per Clause No. I on Page No.35 of the Development Agreement the Society has represented
 and confirmed that there are 102 existing units of Society and the joint signatories are
 considered as one unit. The list of 102 Existing unit is attached as "Annexure C" to the Said
 Development Agreement.

There are total 102 existing Units. Few of them are jointly held by the members. Hence there are 102 Rehab Units and total 163 signatories which includes the joint owners. List of the same is attached to the Declaration

Accordingly, the Promoter is in process of obtaining various approvals /sanctions from MCGM and in pursuant of the same application to register these projects with the MAHARERA Authorities.
