Affidavit cum Declaration of Mr. Shirolawala Biren Vinodbhai duly authorized by the promoter – Venus Infrabuild for Project Venus Pahel A1-03, A1-04 05, vide C.S.No.1299 & 1309/R.S.No. 434/1,2,3, Block No.F & G, TP- 20 (Atladra), FP-85, Moje Atladra, District Vadodara, with area of Plot: 15194 s.q.mtr. and authorization dated 20/11/2019.

- I, Shirolawala Biren Vinodbhai duly authorized by the promoter Venus Infrabuild for project Venus Pahel A1-03, A1-04 05 do hereby solemnly declare, undertake and state as under that;
 - 1. Venus Infrabuild has a legal title to the land on which the development by Venus Infrabuild for Project Venus Pahel A1-03, A1-04 05 is proposed;

- a legally valid authentication of title of such land along with the real estate project is enclosed herewith.

withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- I/we shall take all the pending approvals on time, from the competent authorities.
- I/we have furnished such other documents as have been prescribed by the rules and FOR VENUS INFRABUILD regulations made under the Act.


