

- 7. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That the promoter shall inform the Authority regarding the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under Rule 3 of these rules, within seven days of the said changes occurring.

- 9. That the promoters have furnished such other document as have been prescribed by the rules and regulations under the Act.
- 10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or buildings, the case may be.
