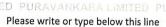

We, the Developers; and we, the Landowner (Developer and Landowner are collectively referred to as "Promoters", unless the context requires otherwise) of the proposed project presently named, "<u>Provident Deansgate Phase 2</u>" do hereby, jointly, and severally as the context requires, solemnly declare, undertake and state asunder:

- 1.
