
Affidavit cum Declaration

- That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a 7. statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That the promoter shall take all the pending approvals on time, from the 8. competent authorities.
- That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
