5. Power supply will be arranged to the proposed M.S building that may come up in the above premises as per provision or regulations in BESCOM. Prevailing at that time.

6. If any existing installation in your premises should be surrendered by clearing all the arrears. before taking up infrastructure work in the premises.

7. NOC is issued only for the purpose of obtaining sanction for the plan of proposed M.S building from the BDA/BMRDA/CMC/Competent authority and it is not a commitment for power sanction from BESCOM. Power supply will be sanctioned when applied for, subject to the feasibility prevailing at that time.

8. The approximate load requirement for the above proposed M.S building is of 170 KWs.

9. The applicant has paid necessary Service Charges Rs. 5000/- Rt. No. 20230001631, CGST Rs. 450/- Vide RT No. 20230001632 and SGST Rs. 450/- Vide RT No. 20230001633 dated 16.01.2023.

9. BESCOM will not be held responsible for any liability arising from the issue of NOC.

11. Land to an extent of 16 mtr X 5 mtr open to sky at the entrance shall be marked in the sanctioned plan for installation of required electrical infrastructure
