- B. A: The Owner/Company was incorporated on 25th March 1937 with the Registrar of Joint Stock Companies, the then Mysore State presently falling under the jurisdiction of the Registrar Companies, Bengaluru, Karnataka. The then Government of His Highness the Maharaja of Mysore has ordered to acquire the certain larger extent of land consisting of Survey Numbers 86, 87/1, 87/2, 72, 73/1, 73/2, 73/3, 73/4, 73/5, 73/6, 73/7, 73/8, 74/1, 81, 82, 74/2, 74/3, 74/4, 74/5, 75/1, 75/2, 75/3, 76/1, 76/2, 78, 83/1, 83/2, 83/3, 83/4, 83/5, measuring 97 acres 03 guntas and Survey Numbers 71/1, 71/2, 79, 80/1, 80/2, 80/3, 90 and 91 measuring 21 acres 21 guntas in Chikkabanavara Village, and the Government Grant certain Survey Numbers 71, 79, 80 and 81 measuring an extent of 53 acres 30 guntas in Soladevanahalli Village and Survey Number 13, measuring an extent of 15 acres in Sasuveghatta Village (viz. the larger extent of the Schedule Property) including the Schedule Property, more fully described below in favour of the Owner/Company for industrial purposes, the cost of acquisition was deposited by the Owner/Company to the Government as per the order dated 15/06/1937 passed by the then Chief Secretary to the Government and accordingly sanction was accorded and conversion charges for usage of land for industrial purposes were also waived by the Government;
