Subject to the following conditions:-


- Power supply will be arranged tapping from F-11 Soladevanahalli Express Feeder, 1. Bank-2 of Soladevanahalli MUSS by using 11 KV XLPE U.G. cable under self execution work.
- You have to carry out all necessary works on self execution basis as per the 2. prepared by BESCOM under self execution and necessary estimate to be supervision charges on 10% of the total cost of the estimate has to be paid.
- While applying for power supply to the said premises, all rules as per KERC 3. Electricity Supply and Distribution code shall be observed.
- You have to obtain approval from Electrical Inspectorate Govt. of Karnataka 4. and same should be furnished while availing power supply if necessary.
- This NOC is issued only for the purpose of obtaining sanction of plan from BDA/BBMP/ competent authorities and is not a commitment for power 5. sanction. from BESCOM. The power will be sanctioned subject to feasibility and as per rules prevailing at that time.
- The existing L.T. installation if any have to be surrendered before taking up the infrastructure work of the proposed residential building. 6.
- If any KPTCL/BESCOM lines are passing through the above premises the 7. same shall be shifted at your cost.
- BESCOM shall not be held responsible for any liability arising from the issue 8.
- This NOC shall be produced at the time of availing permanent power supply 9. to the above proposed layout.
