- 2. The project is still ongoing. We have estimated the cost of the completion to obtain Occupation Certificate/ Completion Certificate, of the Civil, MEP and Allied works, of the Building(s) of the project. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Promoter, Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by shri RAMESH SONEKAR as Quantity Surveyor* appointed by Developer/Engineer, and the fair assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.
- 3. We estimate Total Estimated Cost of completion of the buildings (excluding Land Cost) of the aforesaid project under reference as Rs. 42,83,21,596 including cost of development of common facilities. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the buildings from the concern Nagar nigantl palika/local bodies of Muncipal Corporation Bhopal being the Planning Authority under whose jurisdiction the aforesaid project being implemented.
- 4. The Estimated Cost Incurred till date 21/06/2017(or at the quarter ending on 30/06/2017) is calculated at Rs. 27,33,21,597. The amount of Estimated Cost Incurred is calculated on the basis of amount of Total Estimated Cost
- 5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building(s) of the subject project to obtain Occupation Certificate / Completion Certificate from Municipal Corporation Bhopal (planning Authority) is estimated at Rs 15,50,00,000(From Table B).
