- 3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as **Rs. 16,33,08,000**/- (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building from the **KDMC** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
- 4. The Estimated Cost Incurred till date 31March 2019 is calculated at **Rs. 15,01,90,291**/- (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the base of amount of Total EstimatedCost.
- 5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building of the subject project to obtain Occupation Certificate / Completion Certificate from **KDMC**. (planning Authority) is estimated at **Rs.1,31,17,709**/- (Total of Table A and B).
