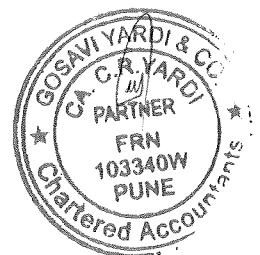

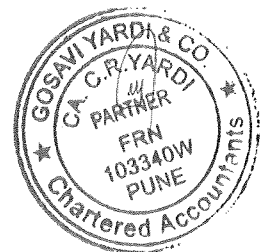
Auditors' Responsibility

We have conducted our examination in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the Institute of Chartered Accountants of India (ICAI) and Standards on Auditing specified under Section 143(10) of the Companies Act 2013. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by ICAI.
7. We have complied with the relevant applicable requirements of the Standard on Quality Control (SQC) 1, Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements.

Opinion

On the basis of our verification referred to in paragraph 5 above and our examination of relevant records and information considered necessary for the purposes of issuing this certificate and on the basis of the information and explanations given to us by the Company read along with the exception's stated in paragraph (B) below, we hereby confirm that we have examined the prescribed registers, if any, books and documents, and the relevant records of Paranjape Schemes (Construction) Limited (Previously known as Matrix Developers Ltd before merger) for the period April 01, 2018 to March 31, 2019 and are of the opinion that:

- A. Paranjape Schemes (Construction) Limited (Previously known as Matrix Developers Ltd before merger) have, based on the books of account, completed 14.03% (Construction) of the project titled Forest Trails Athashri B2 Maha RERA Registration No. P52100000029 located at Plot Bearing Sector No R26, Survey No 16/1 and others, Matalwadi Road, Bhugaon, Mulshi, Pune - 412115
- B. i. Amount collected during the period April 01, 2018 to March 31, 2019 for this project is Rs. 16,41,37,146/- (Rupees Sixteen Crores Forty One Lakh Thirty Seven Thousand One Hundred Forty Six Only).



ii.Total amount collected till date i.e from the date of registration of the project under MAHARERA till 31.03.2019 is Rs. 43,68,47,709/- (Rupees Forty Three Crores Sixty Eight Lakh Forty Seven Thousand Seven Hundred Nine Only).

C. i. Amount withdrawn during the period April 01, 2018 to March 31, 2019 for this project is Rs.11,96,34,900/- (Rupees Eleven Crores Ninety Six Lakh Thirty Four Thousand Nine Hundred Only).

ii.Total amount withdrawn till date i.e from the date of registration of the project under MAHARERA till 31.03.2019 is Rs. 30,02,80,900/- (Rupees Thirty Crores Two Lakh Eighty Thousand Nine Hundred Only).

Paranjape Schemes (Construction) Limited (Previously known as Matrix Developers Ltd before merger) has utilized an amount of Rs 7,43,00,584/- (Rupees Seven Crores Forty Three Lakh Five Hundred Eighty Four Only) for Forest Trails Athashri B2 project out of the amount withdrawn during the year from April 1, 2018 to March 31, 2019 and the withdrawal from the designated bank accounts of the said project has been in accordance with the proportion to the percentage of completion of the project.

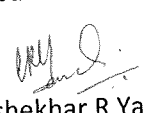
