I Conditions:

- 1) Sanction is accorded for the proposed RESIDENTIAL BUILDING:
 - a) Construction of Tower 1 Club House 2B+G+2 UF, Tower 2 & 3 2B+G+22 UF, Tower 4 B+G+22 UF, Tower 5 G+21 UF, Tower 6 G+21 UF, Tower 7 1 to 21 UF, Tower 8 1 to 14 UF
- 2) Sanction is accorded for Residential use only. The use of the building shall not be deviated to any other use.
- 3) Basements, Ground, First, Second & surface area reserved for car parking shall not be converted for any other purposes. Parking is provided as follows:- Tower 1, 2 & 3 Lower Basement, Tower 1, 2, 3 & 4 Upper Basement, Tower 2, 3, 4, 5 & 6 Ground Floor, Tower 2, 3, 4, 5, 6 & 7 First Floor & Second Floor.
- 4) Development charges towards increasing the capacity of water supply, sanitary and power main has to be paid to BWSSB and BESCOM if any.
- 5) Necessary ducts for running telephone cables, cubicles at ground level for postal services & space for dumping garbage within the premises shall be provided.
- 6) The applicant shall construct temporary toilets for the use of construction workers and it should be demolished after the construction.
- 7) The applicant shall insure all workmen involved in the construction work against any accident / untoward incidents arising during the time of construction.
- 8) The applicant shall not stock any building materials / debris on footpath or on roads or on drains. The debris shall be removed and transported to near by dumping yard.
- 9) The applicant / builder is prohibited from selling the setback area / open spaces and the common facility areas, which shall be accessible to all the tenants and occupants.

- 31) The structures with basement/s shall be designed for structural stability and safety to ensure for soil stabilization during the course of excavation for basement/s with safe design for retaining-walls and super structure for the safety of the structure as well as neighbouring property, public roads and footpaths, and besides ensuring safety of workman and general public by erecting safe barricades.
- 32) The consent for Establishment from the Ministry of Environmental and Forest (MOEF) / SEIAA / KSPCB should be taken before issuing of Commencement Certificate.
- 33) Sufficient two wheeler parking shall be provided as per requirement.
- 34) Traffic Management Plan shall be obtained from Traffic Management Consultant for all high rise structures which shall be got approved from the Competent Authority if necessary.
- 35) The owner / Association of highrise building shall obtain clearance certificate from Fire Force Department with due inspection regarding working condition of Fire Safety Measures installed. The certificate should be produced to the corporation and shall get the renewal of the permission issued once in two years.
- 36) The Owner / Association of the highrise building shall get the building inspected by empanelled agencies of the Fire Force Department to ensure that the fire equipments installed are in good and workable condition, and an affidavit to that effect shall be submitted to the corporation and Fire Force Department every year.
