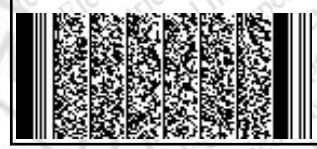
5. Calibration certificates in original of protective devices, CTs, PTs, Energy meters etc., as calibrated by the relay testing and meter testing division of KPTCL and other approved agencies.
6. Earth test results of all the earth electrodes disconnecting all the earth leads from them.
7. A List of authorized persons qualified to operate at the sub-station/ at the works (list shall be signed by both the employees and employer with permit number and validity date)
