TITLE REPORT WITH CERTIFICATE



Re:-Investigation of title to the N.A. land bearing Final Plot Nos.18/2 [Part] & 40 of T.P. Scheme No.41 [allotted in lieu of Revenue Survey Nos. 649/1, 649/2, 650 & 677] admeasuring about 11282 Sq.Mtrs. situate at Moje SOLA Taluka GHATLODIYA in the Registration Sub-District and District of AHMEDABAD.

We have gone through relevant documents / papers produced before us and the search report prepared by our search clerk for last 30 years of the available records of Mamlatdar, Talati and Sub-Registrar of AHMEDABAD (the period of 1980 to 1992 is not available as papers are torn) and on this basis we have investigated the title to the land in question and report as under:

- 28. We have issued a Public Notice in GUJARAT SAMACHAR News Paper dated-18/10/2015 inviting any claim, rights or encumbrances, if any in respect of the said lands; but till today we have not received any claim or objection in response thereof.
- 29. The Town Planning Scheme No.41 made applicable to the said lands and as per the said T.P. Scheme the Final Plot Nos.18/2 & 40 allotted in lieu of Revenue Survey Nos. 649/1, 649/2, 650 & 677.
- 30. Ahmedabad Municipal Corporation by order dated-22/12/2015 bearing Case No. BHNTS/NWZ/261214/GDR/A3422/R0/M1 sanction plan for construction and by Raja Chitthi No. 5115/2612/A3422/R0/M1 granted construction permission for the said land.
- 31..In view of what is hereinabove stated we are of the opinion that the title to the N.A. land in question and belonging to ILESHBHAI NANDUBHAI, **PRIYAVANDANABEN** ILESHBHAI. **MISHAL** ILESHBHAI, SHIVANG ILESHBHAL **MANOJBHAI BECHARBHAI** GAMARA. **KIRTIBHAL** BECHARBHAI GAMARA, VINUBHAI BECHARBHAI GAMARA, ATULBHAI PATEL, DIPAKBHAI BALUBHAI PATEL. KACHRABHAI, JAYANTIBHAI NARAYANBHAI, PRAHLADBHAI JIVANBHAI. RAMESHBHAI JIVANBHAI and RAMESHBHAI VALJIBHAI is clear and free from reasonable doubts and encumbrances; SUBJECT TO [1] Terms and Conditions mentioned in the order dated-07/08/2015, [2] Terms Conditions mentioned in the order dated-08/09/2015, [3] Terms Conditions mentioned in the order dated-12/10/2015, [4] Variation of T.P. Scheme, if any and [5] Any other Rules Acts Laws applicable.
