With reference to above, 'NO Objection Certificate' (NOC) is hereby issued for arranging power supply to an extent of **847 KW (997 KVA)** for Proposed Residential Apartment Building in Favour of M/s. Pushkalam Developers, Represented by It's Partners Sri. Ramesh.M and Smt. Pushpalatha.M Sy No. 30/4 & 30/3, Nimbekaipura Village, Bidarahalli Hobli, Bangalore East Taluk in Sai Garden O&M Unit of Avalahalli Sub-division, Under Self-Execution, Subject to the following conditions:

1. Power supply to your proposed Residential Apartment Building installation at Sy No. 30/4 & 30/3, Nimbekaipura Village, Bidarahalli Hobli, Bangalore East Taluk in Sai Garden O&M Unit of Avalahalli Sub-division in Hosakote Division will be arranged from Existing feeder of F-11 VRKP feeder emanating from 66/11 KV Hosakote Muss by using Coyote + Rabbit ACSR Conductor to an distance of 8.7 KM.
2. You have to develop the infrastructure of providing new feeders and 11 KV lines/UG cable on **self-execution** basis through a Government class-I Electrical contractor by paying necessary supervision charges.
3. The BESCOM lines which are passing through the premises shall be shifted at your cost after payment of supervision charges.
4. This NOC does not apply to the premises where EHT lines are passing through the premises for which NOC is to be obtained from the concerned authorities.
5. The existing installations if any shall be surrendered by clearing all the arrears before taking up infrastructure work in the premises.
6. While applying for power supply to the said Residential Apartment Building at the above address, all rules as per KERC conditions of supply of Electricity in the state of Karnataka shall be observed.

7. Power supply shall be arranged to the said Residential Apartment Building on the provisions of regulations of BESCOM is applicable at that time.
8. This "**NOC**" is issued as requested by you and is not a commitment for power sanction from BESCOM. **Power supply will be sanctioned when applied for, subject to feasibility at the time.**
9. The approximate load requirement of the above said Residential Apartment Building is **847 KW (997 KVA) under LT/HT category as per your application.**
10. Processing charges Rs. 15,000/- collected vide RT No. 20220015444 dated: 29.03.2022.
11. 18% GST on processing charges Rs. 1,350/-x2 Nos collected vide RT No. 20220015442-43 dated: 29.03.2022.
12. This **NOC** is valid for a period of **TWO years** from the date of issue.
