- 1 This report is issued in accordance with the terms of our engagement letter dated 30 June 2019 with Hir-Ban Promoters & Developers ('the partnership firm').
- 2 The accompanying Statement of Project MahaRERA (Registration number P52100010961), which comprises the details of fund collection, withdrawal and utilisation by the Company for the period from 1 April 2018 to 31 March 2019 ('the Statement') has been prepared by the Company's management in accordance with the third proviso to section 4 (2) (I) of the Real Estate (Regulation and Development) Act, 2016 (RERA) read along with the Maharashtra Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosure on Website) Rules, 2017 ('MahaRERA Rules') for the purpose of submitting it to MahaRERA. We have initialled the Statement for identification purpose only.
