2. Considering the above referred documents and after verifying the revenue records that its transpires as under :

It transpired from the revenue record that The Land was in the name of Hirabhai Bhulabhai Patel and after that Hirabhai Bhulabhai Patel died, therefore names of his heirs legal heris namely Ravjibhai Hirabhai Patel were entered in the Revenue Records and the said entry was mutated in the mutation entry no. 1729.

It further transpired from the revenue records that Ravjibhai Hirabhai Patel have executed a will on dtd. 27/01/1982 in favour of Shaileshbhai Jashbhai Patel and he had entered his name in revenue record vide mutation entry No.1855.
