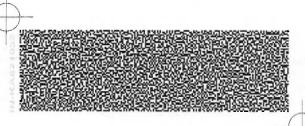

- 1. We state that M/s Icon Kabhini LLP has a legal title to the land on which the development of the proposed project is to be carried out.

A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- 2. We state that the said land is free from all encumbrances.

- 8. We state that the Promoter shall take all the pending approval on time, the competent authorities.

9. We state that the Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.



10. We state that the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
