#### DEVELOPMENT AGREEMENT CUM IRREVOCABLE GENERAL POWER OF ATTORNEY

This Development Agreement cum General Power of Attorney is executed on 21 March 2024 by and between:

Sri/Smt./Kumari LOTHUKUNTA JANARDHAN GOUD, S/O BALAIAH, aged 76 years, Occ: Business, R/o.2-212, KONGARA KALAN, Kongara Kalan, Ibrahimpatnam, Rangareddy, Telangana, 501510.

Hereinafter referred as "LANDLORD"

#### AND

Sri/Smt./Kumari JALLALA LAXMAIAH, S/O IBRAHIM, aged 50 years, Occ. Business, R/o. 6-51,KONGARAKHURDU, Raviryal, Maheshwaram, Rangareddy, Telangana, 501510. (Hereinafter referred as " **DEVELOPER**"

(The terms "Landlord" and "Developer" herein used shall wherever the context so admits mean and include their respective heirs, executors, successors, legal representatives administrators and assignees etc)

Whereas the Landlord is the absolute owner and possessor of land admeasuring 0.2800 Ac.Gts, SurveyNumber 49£/1/1/1/1, 48億, situated at Ferozguda Village, Ibrahimpatnam Mandal, Rangareddy District.

Whereas the Landlord has offered to give the above said property which is hereinafter referred to as schedule property on Development basis to the Developer in the ratio of 27% i.e.,73% of the developed area to the Landlord and 23% of the developed area to the Developer.

The Developer has accepted the offer of the Landlord and agreed to take the Schedule property on Development basis for development of a layout to the Developer in the ratio of 27% i.e., 73% of the area to the Landlord and 27% of the area to the Developer.

In pursuance of offer and acceptance both the parties herein have entered into this Development Agreement.

#### NOW THIS DEVELOPMENT AGREEMENT WITNESSETH AS FOLLOWS:

#### I. Layout Permission:

- a. The Developer shall bear the expenses incurred for obtaining layout permission from HMDA and other Statutory authorities.
- b. The Landlord shall sign on all applications, plans, affidavits, undertakings, declarations, and any other documents required for obtaining development/construction permission from HMDA.

- c. The Landlord shall cooperate with the Developer in submitting the plans and documents with HMDA, for obtaining development permission.
- d. The Developer shall develop as per approved plan.

#### II. Statutory Clearances:

- a. The Landlord is alone responsible for obtaining land conversion proceedings excluding payment of land conversion fee to the concerned authorities and any other NOC's required.
- b. The Landlord/ Developer is alone/jointly responsible for obtaining any other relevant statutory permission, conversions that may be required for obtaining construction permission from HMDA.
- c. The Landlord/ Developer shall bear all the relevant fee, charges, deposits required for land conversion proceedings and all other statutory clearances.

#### III. Percentage:

- a. The total layout area and plots area in and over the schedule propertyshall be shared by both the parties along with the proportionate share of land in the ratio of 27% i.e.,73% to the Landlord and 27% to the Developer.
- b. The Developer shall develop the lay out as per the approval plan issued by HMDA.

#### IV. Title and possession:

- a. The Landlord hereby declare that they are the absolute owners and possessors of the schedule property and no other person or persons have got any right, title and interest over the same.
- b. The Landlord covenant that the schedule property is free from all encumbrances, mortgages, charges, prior sales, third Party claims etc.
- The Landlord is in peaceful, physical Possession of schedule property without any interference or hindrance from any other person or persons
- d. The Landlord shall deliver/has delivered the vacant possession of the schedule property to the Developer.

#### V. Indemnity:

a. The Landlord has agreed to indemnify the Developer against any loss or damages due to defect in title, family disputes third party claims, prior sales, charge, Mortgage, etc. over the Schedule property.

#### VI. Completion of work:

- a. The Developer shall complete the work in all aspects as agreed upon within 18 months from the date of obtaining permission from HMDA and further period of 6 months shall be given as a grace for the valid reasons for finishing works.
- b. The Developer shall bear the expenses incurred towards electricity, water, and watchmen salary during the development period.
- c. The Landlord is not responsible for any loss, defects, claims, workman compensation, etc. during the time of development work and all the claims shall be the sole responsibility of the Developer.

d.The Developer is alone liable and answerable for any defects in development of layout, ciency in service if any arise in future and the Developer alone at its own cost and consequence shall fide redress the grievances of the prospective purchasers of plots of entire building.

#### VII. General:

- a. The Landlord shall co-operate with the Developer in signing all documents, agreements, which are nancial finecessary for the prospective purchasers in obtaining housing loans from banks and institutions.
- b. The Landlord shall clear all taxes, charges which are payable to the statutory authorities up to the date of delivery of possession of schedule property.
- c. That all the original documents of title shall be in the custody of the Landlord and the Landlord shall make available all the original title documents as and when required by the Developer or its nominees for perusal.

#### VIII. Sharing Of Plots/flats:

a. Both the parties shall share their respective share of plots in the ratio of 73% and 27% i.e., 73% to the Landlord and 27% to the Developer and their respective plots shall beincorporated in the Supplement Agreement which shall be registered after obtaining permission from HMDA.

#### X. Irrevocable General Power of Attorney:

- a. The Landlord hereby constitutes, appoint and retain the Developer. i.e., Sri/Smt./Kumari JALLALA LAXMAIAH, S/O IBRAHIM as its lawful attorney in its name and on its behalf to do all the following lawful acts, things and deeds in its name and on its behalf with respect to the 27% share alotted to the Developers share.
- b. To enter into sale agreements with any prospective purchasers of the plots allotted to the share of Developer in the proposed venture and to receive the sale consideration amount.
- c. To sell and register the sale deeds in respect to the plots of the Developers share in favour of developer's nominees or prospective purchasers of Developer's share.
- d. To sign all the documents and papers necessary for execution and presentation of sale deeds before Registration Authorities.
- e. To generally do all acts, things and deeds with respect to the plots allotted to the Developer as perfectly in all aspect as if the owner would do if personally present.
- le and prosecute all civil, criminal, revenue and other legal proceedings to sign plaints, written fif. To statements, petitions, applications, Vakalatnama, to give evidence and to compromise any type of legal proceeding in order to safeguard the interest of owner over the schedule property.
- rm all the acts, deeds, things lawfully done by the said fig. The owner hereby agree to ratify and con attorney i.e. developer, for the above said purposes.
- h. To appoint, retain and remove any agents, architects, engineers, labour, labour contractors, workmen etc.
- i. To sign all applications, declarations etc. with the statutory authorities for obtaining electricity, water and drainage connections.
- j. The Power of Attorney hereby given in favour of the Developer for sale of plots shall be applicable to the plots of Developer entitlement only.

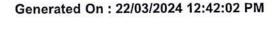
