Affidavit cum Declaration of **IRON KORE PRIVATE LIMITED**, A company registered under the Companies Act, 1956, having its office at 18/1, Nandidurga road, Bangalore - 560 046, promoter of the proposed project "**MAKE BOROUGH**" duly authorized by the promoter of the proposed project;

I, **Mr. GAUTHAM SOMANA CHOTANGADA**, aged about 33 years, S/o. C.A Nandakumar Somana, Director and Authorized Signatory (promoter) of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That We have a legal title to the land on which the development of the project is proposed.
2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by me/promoter is **31/03/2027**.
4. 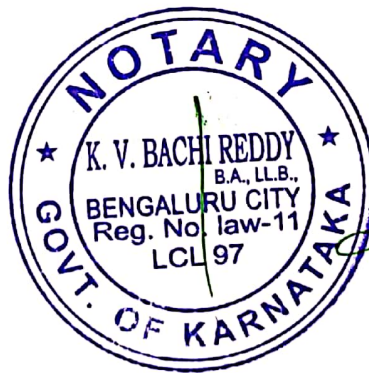

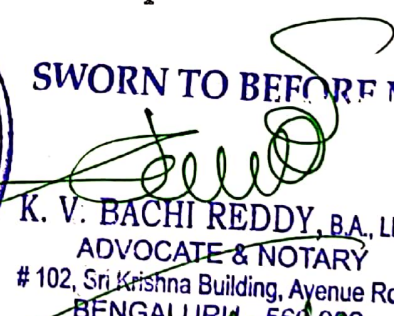
