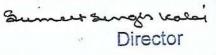

- 1.9 Subject to clause 9.3 the promoter agrees and acknowledges, that the Allottee shall have the right to the apartment or Plot as mentioned below:
- (i) The Allottee shall have exclusive ownership of the Apartment or Plot.
- (ii) The Allottee shall also have undivided proportionate share in the common Areas. Since the share/interest of Allottee in the Common Areas is undivided and cannot be divided or separated the Allottee shall use the Common Areas along with other occupants, maintenance staff, etc. without causing any inconvenience or hindrance to them. Further, the right of the allottee to use the common area shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the promoter shall convey undivided proportionate title in the common area to the association of allottees as provided in the Act.

1.11 The Promoter agrees to pay all outgoings before transferring the physical possession of the apartment to the Allottees, which it has collected from the Allottees, for the payment of outgoings (including land cost, gross rent, municipal or other local taxes, charges for water or electricity, maintenance charges, including mortgage loan and interest on mortgages or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the project). COMPLIANCE OF LAWS RELATING TO REMITTANCES:

The Allottee, if resident outside India, shall be solely 2.1 responsible for complying with the necessary formalities as laid down in Foreign EXCHANGES Management Act, 1999, Reserve Bank of India Act and Rules and Regulations made thereunder or any statutory amendment (modification (s) made thereof and all other applicable (s) laws including that of payment acquisition /sale/transfer of immovable remittance properties in India, etc. and provide the promoter with such permission, approvals which would enable the Promoter to fulfill its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the Rules and regulations of the Reserve Bank of India of any other applicable law. The Allottee

understands and agrees that in the event of any failure on his/her part to comply with the applicable guidelines issued by the Reserve Bank of India, he/she shall be liable for any action under the foreign exchange management Act, 1999 or other laws as applicable as amended from time to time.

2.2 The Promoter accepts no responsibility in this regard. The allottee shall keep the promoter fully indemnified and harmless in this regard. 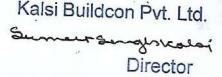
6. CONSTRUCTION OF THE PROJECT OR APARTMENT: -

The allottee has seen the specifications of the Apartment or Plot and accepted the payment plan, floor plans, and layout plans [annexed along with his agreement] which have been approved by the competent authority as represented by the promoter. The Promoter shall develop the project in accordance with the said layout plans, and specifications. 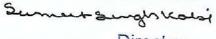
7. POSSESSION OF THE APARTMENT OR PLOT

Schedule for possession of the said Apartment /Plot: The 7.1 Promoter agrees and understands that timely delivery of possession of the Apartment or Plot is the essence of the Agreement However the time may be extendable by 6 months as a grace period without any financial implication. The above time does not include any time wasted due to Force - Majeure events more clearly defined in this Agreement. The promoter, based on the approval plans specifications and assures hand over possession of the apartment or plot unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project or due to non-availability of steel, cement or any other building material; or due to unprecedented price escalation in the rates of key construction materials, such as, cement, steel, etc.. (Force Majeure). If, however, the completion of the Project is delayed due to the FORCE Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the APARTMENT OR Plot, provided that such force majeure conditions are not of a nature which makes it impossible for the contract to be implemented. The Allottee agrees and confirms that in the event it becomes impossible for the Promoter to implement the project due to force Majeure conditions, then this allotment shall stand terminated and the Promoter shall refund to the Allottee the entire amount received by the Promoter from the allotment within 45 days from that date. After refund of the money paid by the Allottee, Allottee agrees that he shall not have any rights, claims, etc. against the promoter and that the promoter shall be



- released and discharged from all its obligations and liabilities under this Agreement.
- Procedure for taking possession -The Promoter upon obtaining 7.2 the occupancy certificate from the competent authority shall offer in writing the possession of the apartment or plot, to the allottee in terms of this agreement to be taken within 3 (three months from the date of issue of such notice and the promoter shall give possession of the apartment or plot to the allottee. The promoter agrees and undertakes provisions to indemnify the allottee in case of failure of fulfillment of any of the formalities, documentation on part of the Promoter. The allottee agrees(s) to pay the maintenance charges as determined by the promoter/association of allottees as the case may be. The Promoter on its behalf shall offer the possession Allottee to the in writing within days of receiving the occupancy certificate of the Project. The ALLottes(S) shall keep indemnified the Promoter against all actions, proceedings, or any losses, costs, charges, expenses, losses or damages suffered by or caused to the Developer, by reason of any breach or non-observance, non-performance of the terms and conditions contained herein by the PURCHASER and/or due to non-compliance with any rules, regulations and/or non-payment of taxes, charges and other outgoings.
 - 7.3 Failure of Allottee to take possession of Apartment or Plot –Upon receiving a written intimation from the Promoter as per clause 7.2, the allottee shall take possession of the Apartment or plot from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement, and the Promoter shall give possession of the Apartment or plot to the allottee. In case the allottee fails to take

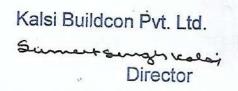
- possession within the time provided in clause 7.2 such allottee shall continue to be liable to pay maintenance charges as applicable.
- 7.4 Possession by the Allottee After obtaining the occupancy certificate and handing over physical possession of the Apartment or plot to the Allottees, it shall be the responsibility of the promoter to hand over the necessary documents and plans including common areas to the association of the Allottees or the competent authority, as the case may be, as per the local laws.
- 7.5 Cancellation by Allottee –The Allottee shall have the right to cancel/withdraw his allotment in the project as provided in the ACT.
 - Provided that where the allottee propose to cancel/withdraw from the project without any fault of the promoter, the promoter herein is entitled to forfeit the booking amount paid for the allotment. The balance amount of money paid by the allottee shall be returned by the promoter to the allottee within 45 days of such cancellation.
- 7.6 Death of the Allottee: In a situation where the allottee dies, the said allotment of the flat would be lawfully transferred in accordance to the deceased's will. If the will does not mention about the same, the allotment would be lawfully transferred to his/her legal heirs. The aforementioned stated transfer would not change the nature of this agreement.
- 7.7 Compensation –The Promoter shall compensate the Allottee in case of any loss caused to him due to defective title of the land, on which the project is being developed or has been developed, in the manner as provided under the Act and the claim for compensation under this section shall not be barred by limitation provided under any law for the time being proferce.



Except for occurrence of a Force Majeure event, if the promoter fails to complete or is unable to give possession of the Apartment or Plot (i) in accordance with the terms of this Agreement, duly completed by the date specified herein or (ii) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under the Act, or for any other reason, the Promoter shall be liable, on demand to the allottees, in case the allottee wishes to withdraw from the project without prejudice to any other remedy available to return the total amount received by hm in respect of the apartment or plot, with interest at the rate specified in the Rules within 45 days including compensation in the manner as provided under the Act. Provided that where if the allottee does not intend to withdraw from the project the promoter shall pay the allottee interest at the rate specified in the rules for every month of delay, till the handing over of the possession of the Apartment or Plot.

8. REPRESENTATION AND WARRANTIES OF THE PROMOTER— The Promoter hereby represents and warrants to the Allottee as follows:

- (i) The [Promoter] has absolute, clear and marketable title with respect to the said land, the requisite rights to carry out development upon the said land and absolute actual, physical and legal possession of the said land for the project.
- (ii) The Promoter has lawful rights and requisite approvals from the competent authorities to carry out development of the Project.
- (iii) There are no encumbrances upon the said land or the project.



(in case there are any encumbrances on the land, provide details of such encumbrances including any rights, title, interest and name of party in or over such land]

- (iv) There are no litigations pending before any court of law with respect to the said land, project or the apartment or plot.
- (v) All approvals, licenses and permits issued by the competent authorities with respect to the project, said land and apartment or plot are valid and subsisting and have been obtained by following due process of law. Further, the Promoter has been and shall, at all times, remain to be in compliance with all applicable laws in relation to the project, said land, Building and apartment or plot and common areas.
- (vi) The Promoter has the right to enter into this Agreement and has not committed or omitted to perform any act or thing, whereby the right, title and interest of the allottee created herein, may prejudicially be affected.
- (vii) The Promoter has not entered into any agreement for sale and/or development agreement or any other agreement/arrangement with any person or party with respect to the said land, including the project and the said apartment or plot which will in any manner affect the rights of allottee under this agreement.
- (viii) The promoter confirms that the promoter is not restricted in any manner whatsoever from selling the said Apartment or plot to the allottee in the manner contemplated in this Agreement.
- (ix) At the time of execution of the conveyance deed the Promoter shall simulated cant, peaceful, physical

- possession of the Apartment or plot to the allottee and the common areas to the Association of the allottees.
- (x) The Schedule Property is not the subject matter of any HUF and that no part hereof is owned by any minor and/or no minor has any right, title and claim over the schedule property.
- (xi) The Promoter has duly paid and shall continue to pay and discharge all governmental dues, rates, charges and taxes and other monies, levies, impositions, premiums, damages and/or penalties and other outgoings whatsoever, payable with respect to the said project to the competent authorities.
- (xii) No notice from the Government or any other local body or authority or any legislative enactment, government, ordinance, order, notification (including any notice for acquisition or requisition of the said property) has been received by or served upon the promoter in respect of the said land and/or the project.

9. EVENTS OF DEFAULTS AND CONSEQUENCES: -

- 9.1 Subject to the Force Majeure clause, the Promoter shall be considered under a condition of Default, in the following events:
- (i) Promoter fails to provide ready to move in possession of the Apartment or plot to the allottee within the time period specified. For the purpose of this clause, ready to move in possession shall mean that the apartment shall be in a habitable condition which is complete in all respects.
- (ii) Discontinuance of the Promoter's business as developer on account of suspension or revocation of his registration under the provision of the Act or the rules or regulations made thereunder.

- 9.2. In case of Default by Promoter under the conditions listed above, Allottee is entitled to the following:
- (i) Stop making further payments to promoter as demanded by the Promoter. If the allottee stops making payments, the promoter shall correct the situation by completing the construction milestones and only thereafter the allottee be required to make the next payment without any penal interest or

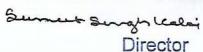

That the allottee hereby undertakes that he/she shall comply with and carry out, from time to time after he/she taken over for occupation an sue the said apartment or plot, all the requirements, requisitions, demands and repairs which are required by any competent authority in respect of the apartment or plot/at his/her own cost.

 After the promoter executes this Agreement, he shall not mortgage or create a charge on the [Apartment/plot/Building] and if any such mortgage or charge is made or create then notwithstanding anything contained in any other law for the time being in force, such mortgage or charge shall not affect the right and interest of the allottee who has taken or agreed to take such [Apartment/Plot/Building].

If the allottee (s) fails to execute and deliver to the Promoter this agreement within thirty days from the date of its receipt by the allottee and/or appear before he sub-registrar for its registration as and when intimated by the Promoter, then the Promoter shall serve a notice to the allottee for rectifying the default, which if not rectified within thirty days from the date of its receipt by the allottee, application of the allottee shall be treated as cancelled and all sums deposited by the allottee in connection therewith including the booking amount shall be returned to the allottee without any interest or compensation whatsoever.

ENTIRE AGREEMENT This Agreement, along with its schedules, constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes any and all understandings, any other agreements, allotment letter, correspondences, arrangements whether written or oral, if any, between the parties in regard to the said apartment/plot/building as the case may be.
- 23. RIGHT TO AMEND -This Agreement may only be amended through written consent of the Parties.

- 25.2 Failure on the part of the promoter to enforce at any time or for any period of time the provision hereof shall not be construed to be a waiver of any provision or of the right thereafter to enforce each and every provision.

26. SEVERABILITY

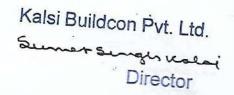

29. PLACE OF EXECUTION -

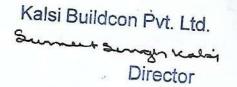
