Affidavit cum Declaration

- That We have a legal title to the land on which the development of the project VENSAI NIVAS is proposed.

That the promoters shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That the promoters shall take all the pending approvals on time, from the competent authorities.
- That the promotes have furnished such other documents as have been prescribed by the Act and the rules and regulations made there under.
- That the promoters shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
