

- (1) I state that I am the authorized signatory of this project and have filed an application for registration of our project "MarkON Madhura Gardens" situated at property bearing Sy. Nos. 49/4 ,49/5,49/6,47/1,47/2 and 47/2, measuring 5 Acre 32 Guntas in Sorahunase, Village, Varthur Hobli, Bengaluru East Taluk, Bengaluru before Karnataka Real Estate Regulatory and Development Authority ('Authority')
- (2) I state that we have a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owners and promoter for development of the real estate project is enclosed herewith.
- (3) I state that the time period within which the project shall be completed by us is 60 Months.
