

#### **Affidavit cum declaration**

Affidavit cum Declaration by the PROMOTERS of M/s. ARATT ALCHEMY ESSENCE LLP for the proposed project **ARATT ALCHEMY ESSENCE**.

produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal is in compliance with the proportion to the percentage of completion of the project.

- **8.** That the PROMOTERS shall take all the pending approvals on time, from the competent authorities.
- **9.** That the PROMOTERS have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That the PROMOTERS shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case maybe, on any grounds.
