## SANCTION OF BUILDING PERMIT AND COMMENCEMENT CERTIFICATE

TO, Ekta Housing Pvt. Ltd., Director - Shri. Ashok G. Mohanani. .

Sub - Sanction of Building Permit & Commencement Certificate in Plot No. – of S. No. 231 of Pathardi Shiwar.

Ref - Your Application & Plan dated: 28 / 03 /2009 Inward No. B5/BP/138.

Sanction of building permit & commencement certificate is hereby granted under section 45 & 69 of the Maharashatra Regional and Town Planning Act 1966 (Mah. of 1966) to carry out development work / and building permits under section 253 of The Bombay Provincial Municipal Corporation Act. 1949 (Bombay Act, No. LIX of 1949) to erect building for **Residential**.

Purpose as per plan duly amended in --- subject to the following conditions.

## CONDITIONS (1 to 42)

- The land vacated in consequence of enforcement of the set-back rule shall form part of public street.
- No new building of part thereof shall be occupied or allowed to be occupied or permitted to be used by any person until completion certificate, under sec. 263 of the Bombay Provincial Municipal Corporation Act, 1949 is duly granted.
- 3) The commencement certificate Building permit shall remain valid for a period of one year commencing from date of its issue & thereafter it shall become invalid automatically unless otherwise renewed in stipulated period Construction work commenced after expiry of period for which commencement certificate is granted will be treated as unauthorized development & action as per provisions laid down in Maharashatra Regional & Town Planning Act 1965 & under Bombay Provincial Municipal Corporation Act. 1949 will be taken against such defaulter which should please be clearly noted.
- 4) This permission does not entitles you to develop the land which does not vest in you.
- The date of commencement of the construction work should be intimated to this office WITHIN SEVEN DAYS
- 6) Permission required Under the provision of any other Act, for the time being in force shall be obtained from the concerned authorities before commencement of work [viz under Provision of Urban Land Ceiling & Regulation Act & under appropriate sections of Maharashatra Land Revenue Code 1986 efc.].
- After completion of plinth, certificate of planning authority to the effect that the plinth is constructed as per sanctioned plan should be taken before commencement of superstructure.

- The building permission is granted on the strength of affidavit & indemnity bond with reference to the provisions of Urban Land [Ceiling & Regulation] Act, 1976. In case a statement made in affidavit & indemnity bond found incorrect or false the permission shall stand cancelled.
- The drains shall be lined out & covered up properly to the satisfaction of Municipal Authorities of Nashik Municipal Corporation.

The effluent from septic tank, kitchen, bath etc. should be properly connected to Municipal drain in the nearest vicinity invert levels of the effluent of the premises should be such that the effluent gets into the Municipal drain by gravity self cleaning velocity.

In case if there is no Municipal drain within 60 meters should be connected to a soak pit to be provided by the owner.

The size of soak pit should be properly worked out on-the basis of tenements% A pigeon hole circular brick wall should be constructed in the centre of the soak pit. Layers of stone boulders, stone metals and pebbles should be properly laid.

- 10) The balconies, ottas & verandas should not be enclosed and merged into adjoining room or rooms unless they are counted into built up area of FSI calculation as given on the building plan. It the balcony ottas & verandas are covered or merged into adjoining room the construction shall be treated as unauthorized and action shall be taken.
- 11) At least FIVE trees should be planted around the building in the open space of the plot. Completion certificate shall not be granted it trees are not planted in the plot as provided under section 19 of the Preservation of Tree Act, 1975.
- The construction work should be strictly carried out in accordance with the sanctioned plan enclosed herewith.
- 13) Copy of approved plan should be kept on site so as to facilitate the inspection of the site by Municipal Corporation's staff from time to time and necessary information in respect of construction work should be furnished whenever required by the undersigned.
- 14) Stacking of building material debris on public road is strictly prohibited. If building material of debris is found on public road the same will be removed by the Authority and cost incurred in the removal of such material shall be recovered from the owner.
- 15) All the conditions should be strictly observed and breach of any of the conditions will be dealt with in accordance with the provision of Maharashatra Regional & Town Planning Act, 1966 and Bembay Provincial Municipal Corporation Act, 1949.
- 16) Nashik Municipal Corporation will not supply water, electricity, road etc. which will be provided by the applicant Colony / Society etc. on their own accord as per the specifications of N.M.C. Applicant should make necessary arrangement for water supply as per the undertaking given. Similarly street lights will not be provided by Municipal Corporation till Electric supply Mains of M.S.E.B: is available at site."
- 17) There is no objection to obtain electricity connection for construction purpose from M.S.E.B.
- 18) N. A. order No. 246/2007 Dated: 31 / 01 /2008 submitted with the application.
- Adequate space from the plot u/r should be reserved for transformer in consultation with M.S.E.B. Office before actually commencing the proposed Construction.
- 20) A) Rs. 1352000+388000+193800/- is paid for development charges w.r. to the proposed Construction vide R. No./B.No. 86/309, 52/340 & 78/346 Dtd:- 22/8/08, 28/4/09 & 29/8/2009.
   B) Rs. 31,79,175/- is paid for development charges w.r. to proposed land development vide R. No./ B.No. 86/309 Dtd:- 22/08/2008.

21) Tree plantation shall be made as per the guidelines of Tree Officer of N.M.C. & NOC shall be obtained before occupation certificate.

- 22) Septic tank & soak pit shall be constructed as per the guidelines of Health officer of N.M.C. & NOC shall be produced before occupation certificate.
- 23) A) Before commencing the construction on site the owner/developer shall install a "Display Board" on the conspicuous place on site indicating following details.

a) Name and Address of the owner/developer, Architect/Engineer and Contractor.

- b] Survey Number / City Survey Number Ward Number of land under reference along with description of its boundaries.
- c] Order Number and date of grant of development permission/redevelopment permission issued by the Planning Authority or any other authority.

d] F.S.I. permitted.

e) Number of Residential / Commercial flats with their areas.

- f] Address where copies of detailed approved plans shall be available for inspection.
- B) A notice in the form of an advertisement, giving all the details mentioned in 23 A above, shall also be published in two widely circulated newspapers one of which should be in regional language.
- 24 ) Proper arrangement in consultation with Telecom Dept., to be done for telephone facilities to be provided in the proposed construction.
- 25) Proper arrangement for rain water harvesting should be made at site.
- Drainage connection charges Rs. 3000/- is paid vide R.No./B.No. 76/0021
   Dtd:- 22 / 08 /2008.
- Nashik Municipal Corporation shall not be responsible for the ownership and boundaries of the land.
- 28) Fly ash bricks and fly ash based and related materials shall be used in the construction of buildings.

29) NMC Tax for Vacant plot shall be paid before Completion.

- Previous tentative layout approved vide letter No: 62 Dtd: 13/11/2003 is hereby treated as cancelled.
- 31) Building shall be planned designed and constructed to ensure fire safety and this shall be done in accordance with part IV fire protection of National Building Code of India, Final NOC of CFO to be obtained before occupancy certificate.
- Building colour scheme within the restricted area of 300m, should be as per the archaeological Dept., requirements.
- 33) Fire prevention fund Rs. 2,11,210+287695+606720/-is paid vide R.No./B.No.8/022 & 01/1073 89/1452 Dtd: 11/08/2008, 28 / 04 /2009 & 29/08/2009.

34) Storm water disposal arrangement should be made at site.

- 35) This permission is given on the strength of DRC No: 259, dtd: 05/01/2009, DRC No: 254 dtd: 05/12/2008 and 13,935.00 Sqmt area utilized is the same.
- 36) The Colony road area 2494.63 Sqmtr & D. P. Road area 1488.00 Sqmt in the name of NMC, 7/12 extract shall be produced before occupancy certificate. D. P. Road area handed over to NMC against F. S. I.
- 37) All internal reads/water pipe lines/street light poles shall be constructed/laid/erected by owner and shall be maintained by the owner at his cost as per undertaken.
- 38) Work should not be started in archaeological area ( upto 300 mt ) before revised NOC and approval to the building plan from Archaeological Dept., Govt, of India.
- 39) This permission is given on the strength of Hon. Commissioner approval dtd: 1/8/2009.
- 40) Occupancy certificate of Eight Floor should be given after the provision of D. C. rule regulize height & Amendment in D. C. Rule.
- 41) The Hardship premium Rs. 23,69,180/- is paid vide R.No./B.No. 82/1441 dtd: 29/8/2009.
- Previously approved building permission vide letter No: 43 dtd; 28/4/2009 is hereby treated as cancelled.
