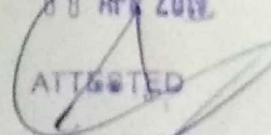
3. That the time period within which the project or phase thereof, as the case may be shall be completed by promoter is **03/04/2021**

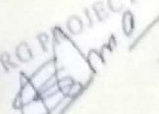
