3. We estimate Total Estimated Cost of completion of the building of the aforesaid project under reference as Rs. 6,85,00,000/- (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate /completion certificate for the building(s) from the Town & Country Planning being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
