We, Mr. Sushil Ghanshyam Agarwal, Mr. Nilesh Ishwarlal Laddad and Mr. Alnesh Akil Somji, authorised partner of the project "Gagan Akanksha Phase I" duly authorized by the promoter/partners of the proposed project do hereby solemnly declare, undertake and state as under;

- 1. That we the promoter have a legal title report to the land on which the development of the project is proposed and a legally valid authentication of title of such land along with the authenticated copies of the agreement between owner and promoter for development of the real estate project is enclosed herewith.
- 2. That the project is free from all encumbrances.

- 7. That we /the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That we / the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.


