SANCTION OF BUILDING PERMISSION AND COMMENCEMENT CERTIFICATE

Sub -: Sanction of Building Permission & Commencement Certificate on Plot No.- 1 to 12, 21 to 37+40 to 42/A of S.No.52/A of Anadwalli Shiwar.

Sanction of building permission & commencement certificate is hereby granted under section 45 & 69 of the Maharashtra Regional and Town Planning Act 1966 (Mah. of 1966) to carry out development work/and building permission under section 253 of The Maharashtra Municipal Corporation Act (Act No.LIX 60.949) to erect/pulding for Residential + Commercial Purpose as per plan duly amended in Subject to the following conditions.

CONDITIONS (1 to 57)

- The land vacated in consequence of enforcement of the set-back rule shall form part of Public Street.
- No new building of part the eof shall be occupied or allowed to be occupied or permitted to be used by any person unit occupancy permission under sec. 263 of the Maharastra Municipal Corporation Act is duly-granted
- The commencement certificate / Building permission shall remain valid for a period of one year commencing from date of its issue & thereafter it shall become invalid automatically unless otherwise renewed in stipulated period Construction work commenced after expiry of period for which commencement certificate is granted will be treated as unauthorized development of the following the period of the period commenced after expiry of period for which commencement certificate is granted will be treated as unauthorized development of the period of
- This permission does not entitle you to develop the land which does not vest in you.
- The date of commencement of the construction work should be intimated to this office WITHIN SEVEN DAYS
- Permission required under the provision of any other Act, for the time being in force shall be obtained from the concerned authorities before commencement of work [viz under Provision of Urban Land Ceiling & Regulation Act & under appropriate sections of Maharashtra Land Revenue Code 1966.].
- After completion of plinth, certificate of planning authority to the effect that the plinth is constructed as per sanctioned plan should be taken before commencement of superstructure.
- Building permission is granted on the strength of affidavit & indemnity bond with reference to the provisions of Urban Land [Ceiling & Regulation] Act, 1976. In case a statement made in affidavit & indemnity bond found incorrect or false the permission shall stand cancelled.
- The balconies, ottas & varandas should not be enclosed and merged into adjoining room or rooms unless they are counted into built up area of FSI calculation as given on the building plan. If the balconies, ottas & verandas are covered or merged into adjoining room the construction shall be treated as unauthorized and action shall be taken.

- At least FIVE trees should be planted around the building in the open space of the plot 10. Completion certificate shall not be granted if trees are not planted in the plot as provided under section 19 of the reservation of Tree Act, 1975.
- The drains shall be lined out & covered up properly to the satisfaction of Municipal Authorities of Nashik Municipal Corporation.

The effluent from septic tank, kitchen, bath etc. should be properly connected to Municipal drain in the nearest vicinity invert levels of the effluent of the premises should be such that the effluent gets into the Municipal drain by gravity with self cleaning

In case if there is no Municipal drainage line within 30 meters premises then effluent outlet should be connected to a soak pit.

The size of soak pit should be properly worked out on-the basis of number of tenements a pigeon hole circular brick wall should be constructed in the centre of the soak pit Layers of stone boulders, stone metals and pebbles should be properly laid.

- The construction work should be strictly carried out in accordance with the sanctioned plan enclosed herewith.
- 13. Copy of approved plan should be kept on site so as to facilitate the inspection of the site by Municipal Corporation's staff from time to time and necessary information in respect of construction work should be furnished whenever required by the undersigned.
- 14. Stacking of building material debris on public road is strictly prohibited. If building material of debris is found on public road the same will be removed by the Authority and cost incurred in the removal of such material shall be recovered from the owner
- 15. All the conditions should be strictly observed and breach of any of the conditions will be dealt with in accordance with the provision of Maharashtra Regional & Town Planning
- Act, 1966 and The Maharastra Municipal Corporation Act.

 Applicant should make necessary arrangement of oater for construction purpose as per undertaking given. Similarly store lights will not be provided by Municipal Corporation till Electric supply Mains of M.S.F.B. is available at site. 16.
- There is no objection to obtain electricity connection for construction purpose from M.S.E.B.
- 18. Septic tank & soak pit shall be constructed as per the guidelines of sewerage department of N.M.C. & NOC shall be produced before occupation certificate.
- Adequate space from the plot u/r should be reserved for transformer in consultation with 19 M.S.E.D.C.L. Office before actually commencing the proposed construction.
- Drinking water & adequate sanitation facility including toilets shall be provided for staff & 20. labour engaged at construction site by owner/Developer at his own cost.
- While carrying out construction work, proper care shall be taken to keep noise level 21. within limits for various categories of zone as per rules laid down vide Government Resolution of Environment Department Dated 2004/2009 for Noise Pollution or as per latest revision/ Government GRs.
- As per order of Urban Development of Government of Maharashtra, vide 22. TPS2417/487/pra.kra.217/2017/UD-9Dated-7/8/2015 for all building following condition shall apply.
 - A) Before commencing the construction on site the owner/developer shall install a "Display Board" on the conspicuous place on site indicating following details.
 - Name and Address of the owner/developer, Architect/Engineer and Contractor.
 - Survey Number/City Survey Number/Ward Number of land under reference b] along with description of its boundaries.
 - Order Number and date of grant of development permission/redevelopment c] permission issued by the Planning Authority or any other authority.
 - d] F.S.I. permitted.
 - Number of Residential/Commercial flats with their areas. e
 - Address where copies of detailed approved plans shall be available for f]
 - B) A notice in the form of an advertisement, giving all the details mentioned in 22A above, shall also be published in two widely circulated newspapers one of which should be in regional language. Failure to comply with condition 22 (A) action shall be taken by NMC.
- 23. Proper arrangement to be done on sits for telephone facilities in consultation with Telecom Department.
- This permission is given on the basis of Title search report submitted by 24. owner/developer, Nashik Municipal Corporation shall not be responsible for the ownership and boundaries of the land.

- Fly ash bricks and fly ash based and related materials shall be used in the construction of buildings.
- Fanning shall be made and maintained as per the provisions of DCPR on site.
- Provision of rain water harvesting shall be made at site as per rule no 33 of DCPR and also as per Hon. Commissioner order No./TP/Vasi/392/2017 dt.05/6/2017 NOC shall be produced from Rain water harvesting cell in plot area more than 500 sqm.
- 28. The building Permission is granted on the strength of "Labour Code on occupational safety, health and working conditions, 2018" Therefore all the conditions mentioned therein are applicable to this commencement and shall be followed strictly. Nashik Municipal Corporation shall not be responsible for breach of any conditions mentioned theirin.
- 29. NMC shall not supply water for construction purpose.

- 40. This permission is given on the strength of DRC No:460 Dt:19/04/2011 and 6014 96 Sq.mt. TDR area utilized from the same.
- Previously approved building permission vide C.C.No: A1/523/6079 Dt:27/01/2017 is hereby as cancelled.
- This permission is given on the strength of provisional fire NOC from CFO, N M C, vide letter No: NMC/FIRE/WS/II/ASSEMBLY(Temple) 05/19 Dt:03/01/2019 & conditions their in strictly followed.

Building shall be planned designed and constructed to ensure fire safety and this shall be done in accordance with part IV fire protection of National Building Code of India Final NOC of CFO to be obtained before occupancy certificate & & conditions mentioned in it should be strictly observed.
- 44. This permission is given on the basis of conditions mentioned in Hon, Labour Commissioner letter No. vide letter No: Nahapra-112010/pr.No.212/kam-2 Date: 30/12/2010 From Ministry of Labour Dept. & the Conditions mentioned should be strictly observed.
- Provision of Grey water reuse shall be made as per rule no.34 of DCPR.
- 46. All safety measures & precaution shall be taken on site during construction with necessary signage/display board on site.

- Parking area should be paved & kept open for parking purpose only

- 52. It is necessary to cover entire construction site with Green Net / Shed Net for reduction of dust in air so as to avoid air pollution & Geo tag photo should be produce be for occupancy certificate.
- It is necessary to provide set of Dry and Wet dust bins for segregation of waste.
- Facility for differentially able persons shall be made.
- 55. Provision of Machanical Lighit & ventilation should be made wherever required
- 56. This permission is given on the strength of precode basis.
- 57. As per order of Hon. Commissioner bearing No.Nanivi/vashi/17/2020 dated 24/09/2020 applicant has requested to get benefit of installment for development charges. The applicant has paid Ist of Rs. 20,14,830/- is Paid via R.No./B.No.66/744 Dt:23/09/2020 which is 30% of total development charges Rs. 67,16,100/-

IInd installment of Rs. 26,86,440/- which is 40% of total development charges along with applicable interest rate of 8% per annum should be paid at the time of plinth completion or one year from the date of issue of the C.C. whichever is earlier.

And IIIrd installment of Rs. 20,14,830/- which is 30% of total development charges along with applicable interest rate of 8% per apply should be paid at the time of Occupancy Certificate or three year from the vate of issue of the C.C. whichever is earlier.

If the applicant fails to pay IInd & HIrd isnatalments within specified time, then recovery of the installment will be made at the rate of 18% per annum interest as per the section 124 E (3) of M.R.T.P. Act and C.C. Issued will be treated as cancelled.
