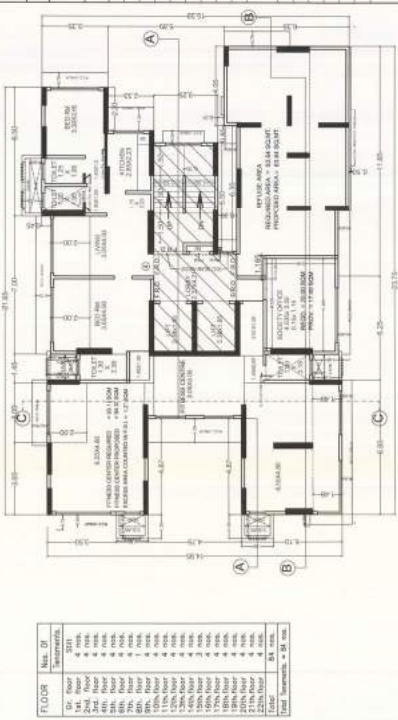

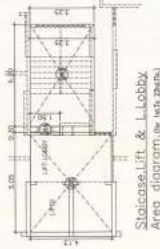
8TH FLOOR PLAN

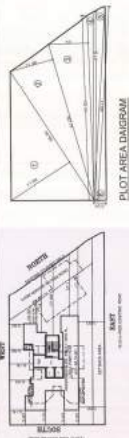

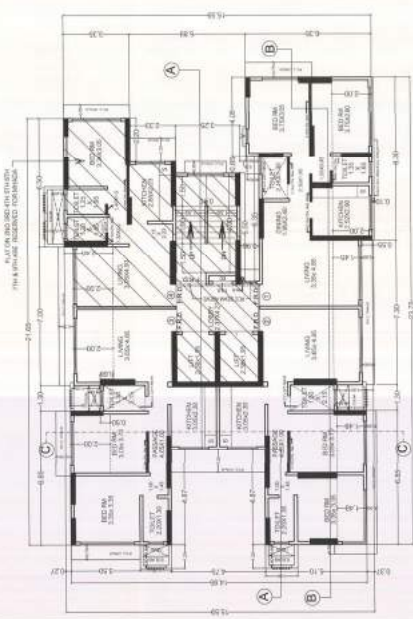

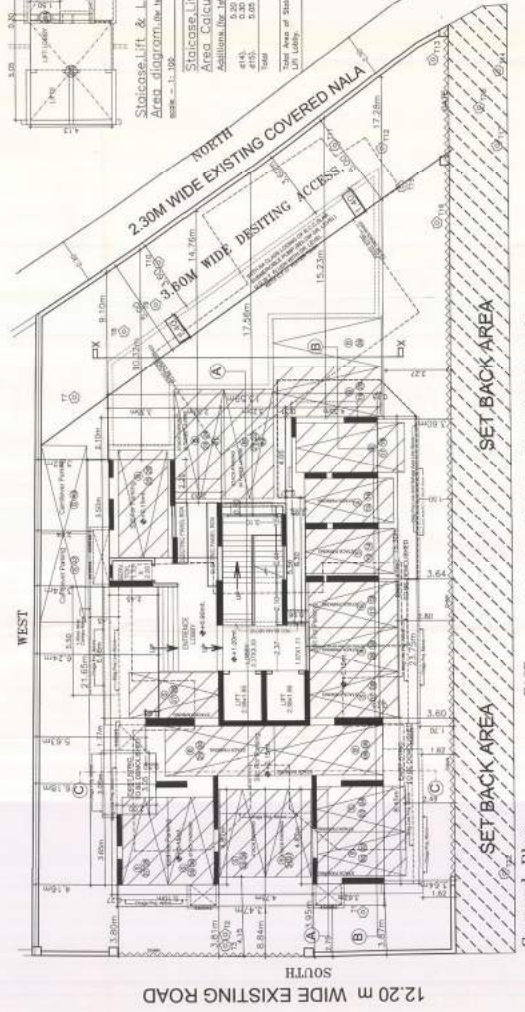
