That the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of Section 4 of the Act and under rule 3 of these rules within seven days of the changes occurring.

That the promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
