The Pahani Pathrika for the year 1997-98 issued by MRO, Keesara Mandal shows that 1)Madduri Eshwaramma, 2)Madduri Nagabhushanam Reddy, 3)Madduri Krishna Reddy & 4)Madduri Madhava Reddy was pattedar and possessor of all the agricultural land in Survey No.43, admeasuring Ac.15-21 Guntas, situated at Kapra Village, Keesara Mandal, Ranga Reddy District.

The Regd. DAGPA No.6018/2024 executed by Sri Kanthamaneni Haradayal in favour of M/s.Aditya Developers Rep., by its Managing Partner: Sri Kura Srinivas in respect of all that the part and parcel of Plot Nos.124 and 125, in Survey No.43, admeasuring 646 Sq.Yards or 540.05 Sq.Meters, situated at Sri Sai Suma Enclave, Yellareddyguda, Kapra Village and Mandal, Medchal-Malkajgiri District.

The Partnership Deed executed by and between Sri Kura Srinivas, Sri Gudala Santosh Kumar, Smt.Shireesha Domakonda and Smt.Domakonda Swarna Latha forming a partnership firm under the name and style of M/s.Aditya Developers to carry on the business of all types of construction works, developments, real estates, property management, property consulting services, etc. and Sri Kura Srinivas shall be Managing Partner and is authorized to sign the documents on behalf of the firm.

The Acknowledgement of Registration of Firm issued by Registrar of Firms shows that the name of the firm, M/s.Aditya Developers has

been entered in the register of firms as vide No.1895/2024 at Medchal-Malkajgiri.

The Regd. Simple Mortgage Deed No.177/2025 executed by Sri Kanthamaneni Haradayal Rep., by his DAGPA Holder: M/s.Aditya Developers Rep., by its Managing Partner: Sri Kura Srinivas in favour of the Commissioner, GHMC in respect of all that the 10% of area i.e. 162.44 Sq.Yards (135.80 Sq.Meters) or 1461.96 Sq.Feet in Fifth Floor, Plot Nos.124 and 125, in Survey No.43, admeasuring 646 Sq.Yards or 540.05 Sq.Meters, situated at Sri Sai Suma Enclave, Yellareddyguda, Kapra Village and Mandal, Medchal-Malkajgiri District.

The Online Building Permission vide Permit No.4401/GHMC/LBN/2025-BP issued by Commissioner, GHMC shows that permission was accorded to Sri Kanthamaneni Haradayal for construction of Residential Building consisting of Stilt + 5 Upper Floor, on Plot Nos.124 and 125, in Survey No.43, to an extent of 539.9 Sq.Meters, situated at Sri Sai Suma Enclave, Yellareddyguda, Kapra Village and Mandal, Medchal-Malkajgiri District.

- 2. Encumbrance Certificate from SRO in respect of the schedule of property.

IX. CERTIFICATE OF TITLE:

As per the documents placed before me, I am of the considered opinion that subject to the observations made above and the charge created for financial assistance, Sri Kanthamaneni Haradayal Rep., by his DAGPA Holder: M/s.Aditya Developers Rep., by its Managing Partner: Sri Kura Srinivas is having an absolute clear and marketable title in respect of the schedule of property referred above.

Hence, from the above referred documents, it is clear that the schedule of property referred above, if offered as security by way of equitable mortgage and any document/s executed in the manner required under law will satisfy the requirement of creation of equitable mortgage.
