



- It appears from the revenue record, that Shri.Sahadu Genu Bhondave died on dtd.13/12/79 leaving behind widow 1]Smt.Venubai Sahadu Bhondave, son 2]Shri.Eknath Sahadu Bhondave,fourdaughters3]Sau.Bhamabai Mahadusapkal,4]Sau.Janabai@abanPawar,5]Sau.Kankabai Dattatray rakshe, 6]Sau.Bababai Subhash Valhekar and 7]Chababai Sahadu Bhondave, as legal heirs who became exclusive owners of land bearing Survey no.60/2 and their names were mutated on 7/12 extract as Owners vide Mutation entry no.1747.



- 4] It appears from the record that, land owners 1]Shri.Eknath Sahadu Bhondve, 2]Smt.Venubai Sahadu Bhondve, 3]Chababai Sahadu Bhondve sold 00Hector 60Are land out of Survey no.60/2/1 in favor of 1]Shri.Sopan Shankar Bhondve, 2]Shri.Vittal Shankar Bhondve by Sale Deed, which is registered at the office of Sub Registrar, Haveli at serial no.1185/82 on 26/02/82, accordingly the effect of the aforesaid sale deed is mutated on the new 7/12 extract of Survey no.60/2/3 vide mutation entry no.1954.
- 5]It appears from the record that, land owners 1]Sau.Bhamabai Mahadu Sapkal, 2] Sau.Janabai Baban Pawar,3]Sau.Kankabai Dattatray Rakshe, 4]Sau.Bababai Subhash Valhekar filed application and made statement before Circle officer and released their share in respect of land bearing Survey no.60/2/1 in favor of Shri.Eknath Sahadu Bhondve, accordingly the effect was mutated on 7/12 extract of Survey no.60/2/1 vide mutation entry no.1941.
- 6]It appears from the record that, land owners 1]Sau.Bhamabai Mahadu Sapkal, 2] Sau.JanabaiBabanPawar,3]Sau.Kankabai Dattatray Rakshe, 4]Sau. Bababai Subhash Valhekar released their rights in respect of land bearing Survey no.60/2/1 by Release Deed in favor of Shri.Eknath Sahadu Bhondve and others, the said Release Deed is registered on 06/11/97 in the office of Sub Registrar, Haveli no.5 at serial no.9444/97 accordingly the effect was mutated on 7/12 extract of Survey no.60/2/1 vide mutation entry no.1941.
- 7]It appears from the revenue record, that land owner Smt.Venubai Sahadu Bhondve died on dtd.7/11/99 leaving behind 1]Eknath Sahadu Bhondave, and 2]Chababai Sahadu Bhondve, as legal heirs who became owners of share of deceased in respect of land bearing Survey no.60/2/1 and their names were mutated on 7/12 extract as Owners vide Mutation entry no.7045.
- 8]It appears from the record that, land owner Shri.Eknath Sahadu Bhondve executed Gift Deed and gifted his undivided share out of land bearing Survey no.60/2/1 to extent of 01Are in favor of 1] Shri.Dhananjay Eknath Bhondve and 2]Shri.Rahul Eknath Bhondve, the said Gift Deed is

registered on 18/02/13 in the office of Sub Registrar, Haveli no.14 at serial no.1331/13, accordingly the effect was mutated on 7/12 extract of Survey no.60/2/1 vide mutation entry no.8409.

- 9]It appears from the record that, land owner Smt.Chabai [Chabubai] Sahadu Bhondve executed Gift Deed and gifted her ½ undivided share out of land bearing Survey no.60/2/1 in favor of 1] Shri.Dhananjay Eknath Bhondve and 2]Shri.Rahul Eknath Bhondve, the said Gift Deed is registered on 6/02/13 in the office of Sub Registrar, Haveli no.18 at serial no.1061/13, accordingly the effect was mutated on 7/12 extract of Survey no.60/2/1 vide mutation entry no.8410.
- 10] It appears that land owners 1]Shri.Eknath Sahadu Bhondave, 2]Shri.Dhananjay Eknath Bhondave, 3]Shri.Rahul Eknath Bhondave obtained commencement certificate from PCMC in respect of land bearing Survey no.60/2/1[Part], the said certificate bares no.BP/Ravet/53/13.
- 11] It appears from the record that, land owners 1]Shri.Eknath Sahadu Bbondave, 2] Shakuntala Eknath Bhondave, 3]Seema Eknath Bhondve alias Seema Sudhir Sathe, 4] Varsha Eknath Bhondve alias Varsha Ganesh Valhekar released their rights in respect of land bearing Survey no.60/2/1 by Release Deed in favor of Shri.Dhananjay Eknath Sahadu Bhondve and Rahul Eknath Bhondave, the said Release Deed is registered on 28/09/15 in the office of Sub Registrar Haveli no.24 at serial no.7795/15 accordingly the effect was mutated on 7/12 extract of Survey no.60/2/1 vide mutation entry no.9535.
- 12]It appears that land owners 1]Shri.Dhananjay Eknath Bhondave, 2]Shri.Rahul Eknath Bhondave obtained revised commencement certificate from PCMC in respect of land bearing Survey no.60/2/1, part, the said certificate bares no.BP/Ravet/09/17.
