- (i) That seventy per cent of the amounts to be realised hereinafter by us for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

I further say and declare that the amounts from the separate account shall be withdrawn in accordance with Rule 5.

I further say and declare that we shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

I further say and declare that we shall take all the pending approvals on time, from the competent authorities.

I further say and declare that we shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

I further say and declare that we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

I further say and declare that we shall not discriminate against any allottee at the time of allotment.
