AFFIDAVIT

Affidavit of Mr. Bipin Agarwal duly authorized by the promoter (M/s IITL-NIMBUS THE EXPRESS PARK VIEW) of the proposed project 'THE EXPRESS PARK VIEW II-LOW RISE APARTMENTS', vide authorization letter dated 29th October, 2020.





- I, **Bipin Agarwal**, authorized by the promoter of the proposed project **'THE EXPRESS PARK VIEW II-LOW RISE APARTMENTS'** do hereby solemnly affirm, undertake and state as under:
 - That M/s IITL-NIMBUS THE EXPRESS PARK VIEW have/ has the legal title to the land on which the development of the proposed project 'THE EXPRESS PARK VIEW II-LOW RISE APARTMENTS' is to be carried out.
 - 2. That the promoter has been sanctioned a credit facility/ loan amounting to INR 20,00,00,000/- (INR Twenty Crores Only) vide sanction letter dated 22.05.2019 by Bank of India for completion/ construction of the project and further a credit facility/ loan for an amount of INR 3,00,00,000/- (INR Three Crores Only) vide sanction letter dated 13.08.2020 by Bank of India under Star Guaranteed Emergency Credit Line ("Star GECL") Scheme to meet the temporary liquidity mismatch caused by the effect of Covid-19. The said credit facility has been granted against mortgage of project land "THE EXPRESS PARK VIEW" situated at GH-03, Sector CHI-V, Greater Noida, U.P.
 - 3. That out of the above sanctioned credit limit amounting to INR 20,00,00,000/- (INR Twenty Crores Only), the promoter has already availed the loan/ credit facility for an amount of INR 15,00,00,000/-(INR Fifteen Crores Only) from the Bank of India and the rest of the remaining limit is to be availed in future.
 - 4. That out of the above sanctioned credit limit amounting to INR 3,00,00,000/- (INR Three Crores Only), the promoter has availed the entire credit facility of INR 3,00,00,000/- (INR Three Crores Only) from Bank of India.

- 5. That as per the sanction letter dated 22.05.2019 duly received by the promoter for the credit facility of INR 20,00,00,000/- (INR Twenty Crores Only) from the Bank of India, the repayment schedule is bifurcated into 5 quarterly instalments commencing after 11 months from the 1st disbursement, i.e., the first repayment was to be repaid from April, 2020. However, the promoter has availed the benefit of moratorium period therefore the first installment was to be repaid from November, 2020.
- 6. That as per the sanction letter dated 13.08.2020 duly received by the promoter for the credit facility of INR 3,00,00,000/- (INR Three Crores Only) from the Bank of India, the repayment schedule is bifurcated into 36 monthly instalments commencing after 12 months from the 1st disbursement, i.e., the first repayment would stand to be repaid from September, 2021.
