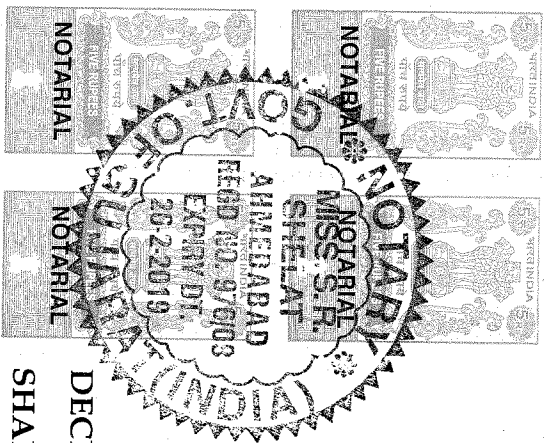

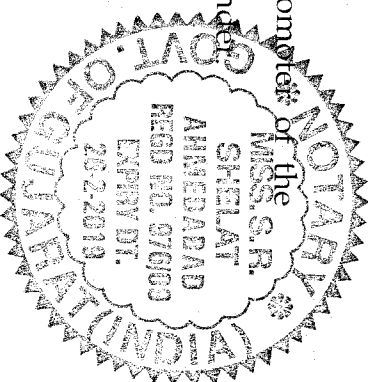

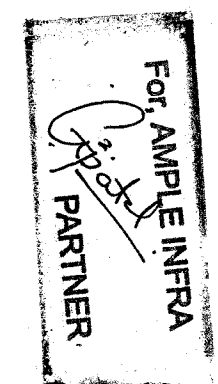


1. That the promoter M/s Ample Infra partnership Firm has not taken any loan from any Bank and has not created charge over the said project in this respect.

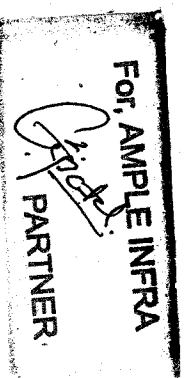

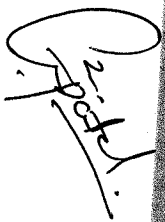

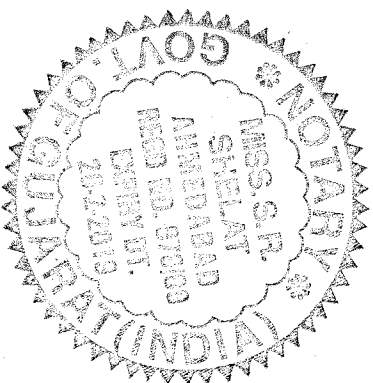
