The environmental clearance is sought for Proposed Group Housing Project at Plot No. Plot No. GH 01/C, Sector 10, Greater Noida, District-Gautam Budh Nagar, U.P. M/s Jatasya Promoters Pvt. Ltd.

2. Five 5 towers with maximum G+18 floors are proposed.

Total water requirement is proposed as 213 KLD for the project.
