- 1. That we have a legal title to the land on which the development of the project is proposed.00

- 9. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- That we promoter shall not discriminate against any allottees at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
