- 13. The 11 kV systems shall be as per BESCOM standard practices.

- 15.In future, if the load exceeds 7500 KVA, as per the notification No. KERC/17/1008/CoS-RoE/DDD/22-23/2184 Dated:11-01-2023 and its amendment's the developer/applicant Owner shall provide space for erection of sub-station and also bear the entire charges of such sub-station and associated lines/equipment's.
- 16. The applicant has to obtain suitable permissions / NOC from railway department, Highway authority, Local panchayath office for laying UG cable on his own under selfexecution basis.
- 17. BESCOM will not be held responsible for any liability/ disputes arise from the issue of this NOC.
