





AFFIDAVIT CUM DECLARATION

Affidavit cum declaration of Ms. SHRI ANJANEYA DEVELOPERS PVT. LTD., through its director Mr. Anil Ashtankar, Promoter of the Proposed project.

Anil Ashtankar, the Authorized Signatory of SHRI ANJANEYA DEVELOPERS PVT. LTD., Promoter of the proposed project, duly authorized by the Promoter of the Proposed project named and styled as ANJANEYA NAGAR V having Land admeasuring 14.79 hectare R., Rental Rs. 5.25/-, PSK 74 being portion of the entire land bearing Khasra No. 117,118,119/2,125,126,134/1,127/1,134/2,135,139, Mouza – WARANGA, situated at Tahsil – Nagpur (Rural) and District - NAGPUR, do hereby solemnly declare, undertake and state as under:





- 1. That promoter has a legal title Report to the land on which the development of the project is proposed.
- 2. That the project land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by the promoter from the date of registration of the project is 31/12/2027.
- 4.  - That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That the promoter shall take all the pending approvals on time from the competent authorities.
- 8. That the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

- 9. That the promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building as the case may be.




