- 8. That we the promoters shall take all the pending approvals on time, from the competent authorities.

- 9. That the existing Far Area Ratio (FAR) in relation to the said Project is 1.75, as detailed in the Sanctioned Plan.
- 10. That, in the event of any TDR in addition to the existing FAR becomes available in respect of the said Land, we reserve the right to utilize the additional TDR by putting up additional construction/s on the Blocks comprised in the Project;
