K.R. PURA HOBLI, BANGALORE EAST TALUK.

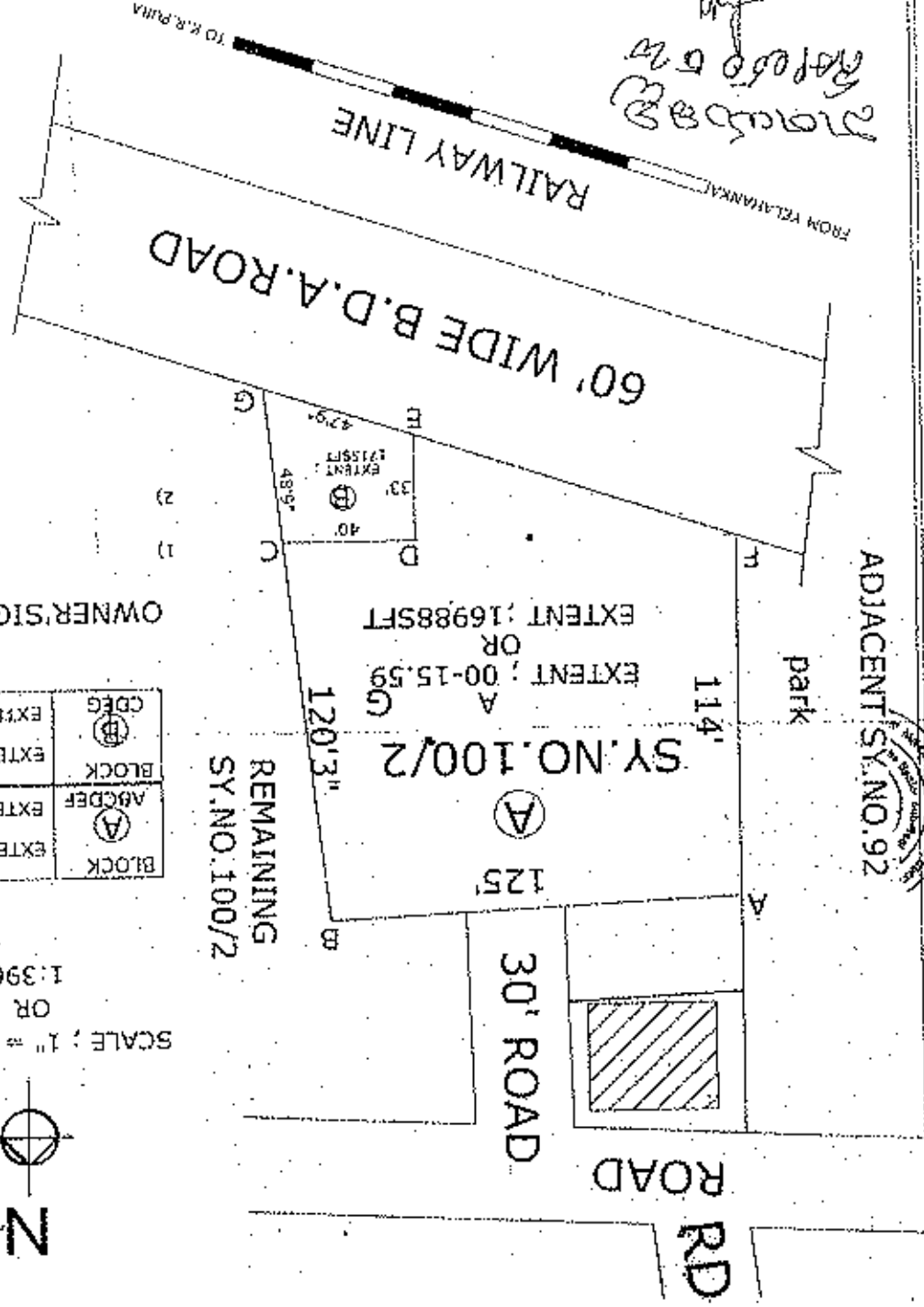
