2. Interest at the rate of 1.5% per month shall be charged on all delayed payment of instalment for the total period of three months after which the company shall be at liberty to cancel the application.
3. The applicant at his /her discretion may avail housing loan from a bank / financial institution. The company shall, under no circumstance, be held responsible for non sanction of the loan to the applicant for whatsoever reason. The payment of instalment to the company shall not be linked to the housing Loan availed / to be availed by the applicant.
4. The company is authorized to raise loan by creating mortgage of the complex land from any bank / financial institution / agency and the applicant(s) will have no objection in this regard.
